One of the unique highlights of HELP[®] is the unlimited assistance enrollees receive for their estate planning needs. All employees enrolled in HELP[®] are entitled to receive personalized Simple Wills, Living Wills, and various Power of Attorney documents, and your spouse can receive the same documents as well.

In addition, your personalized Wills can be customized to include a simple minor's trust, and as long as you are enrolled in HELP[®], you receive unlimited changes to all of the documents.

HOW DO I ENROLL?

You can enroll in HELP[®] during your worksite's designated open enrollment period. HELP[®] is an annual enrollment, so you are enrolled for one full year from the effective date of your enrollment, with automatic rollover renewal each year unless you cancel at any time during open enrollment.

The payroll deduction of \$6.23 bi-weekly covers you, your spouse and dependent children (up to and including age 23).

Once enrolled, you will receive a welcome letter and enrollment cards in the mail. You can access your benefit at 12:00am the date your coverage becomes effective. There are no waiting periods.
