PETER LANGMAN, PHD is a psychologist whose research on school shooters has received international recognition, with more than 450 media interviews in 27 countries. He is the author of *Why Kids Kill* and *School Shooters*, and has conducted training for the Department of Homeland Security, FBI Headquarters, the FBI National Academy at Quantico, the National Counterterrorism Center, and many organizations and school districts around the country. He is a researcher with the National Threat Assessment Center of the United States Secret Service. His work has been cited in congressional testimony on Capitol Hill and his recommendations on school safety were presented to President Barrack Obama by the CEO of American Psychological Association.

BARBARA DALY, MA, CTM is the director of Training & Technology at New York Presbyterian Hospital. She retired from the Federal Bureau of Investigation's (FBI) New York Office in April 2019 after 30 years of service. She supervised the FBI/NYPD Joint Violent Crime Task Force from 2008 to 2017 and served as the New York Office's primary Behavioral Analysis Unit (BAU) coordinator from 2007 to 2019. Barbara earned a master's degree in forensic psychology from the John Jay College of Criminal Justice.

ERIC J. WEISS, DEPUTY UNITED STATES MARSHAL began his federal law enforcement career in 2002, and in 2010, he became a member of the Protective Intelligence Unit (PIU) in the Southern District of New York. As a member of PIU, Deputy Weiss was tasked with investigating threats against Justices of the Supreme Court, United States District, Magistrate, Bankruptcy and Court of Appeals Judges, federal prosecutors, jurors, and witnesses. In 2017, he became a task force officer on the FBI's Joint Terrorism Task Force. Deputy Weiss holds a Bachelor of Science degree in criminal justice from the State University of New York. He is president of the Northeast Chapter of The Association of Threat Assessment Professionals.

JENNIFER ROMEI, PHD is a partner and chief operations officer at Exi-Venn, a company that is at the forefront of developing data-driven, strategic solutions for threat assessment professionals. A licensed psychologist with more than 20 years of experience, she provides the clinical insight behind Exi-Venn's methodology. She is licensed to practice in both New York and New Jersey and has a private practice in Ridgewood, New Jersey where she conducts psychotherapy and forensic evaluations.
